I WILL:

- Follow ALL guidelines set by Ausblick Ski Hill.
- Use indoor facilities that are a part of Ausblick Ski Hill at my own risk, acknowledging that ART does not encourage or condone the usage of any indoor facilities that are a part of the Ausblick Ski Hill, outside of an emergency.
- Report any signs, symptoms or known exposure to COVID-19 and I WILL NOT COME TO TEAM SESSIONS OR TRAINING FACILITIES if they show symptoms or have been knowingly exposed to the virus.
 - Signs symptoms: fever, new loss of smell or taste, nausea, vomiting, diarrhea or digestive issues, cough, sore throat, shortness of breath, chills, muscle pain
 - Participate willingly in all wellness checks
- Maintain communication with my head coach and/or board member if I experience symptoms or have knowledge of direct exposure
 - Report positive COVID-19 test
 - Follow appropriate CDC guidelines before returning to practices
- Follow Local and State protocols regarding COVID-19
- Follow coach/team guidelines regarding practice/training group sizes
- Follow coach/team guidelines regarding symptom screening and mask-wearing
- Not share water bottles, food/drinks, and personal gear
- Wash/disinfect my hands frequently before and after practice.
- Avoid touching teammates and coaches
- Maintain appropriate social distancing
- Cover my face with my own elbow when sneezing and coughing
- Respect teammates personal decisions regarding their own health and safeguards
- Use my best judgment about germ spreading and containment during and outside of team training sessions
- Failure to follow disclosure statement could result in removal from Ausblick Race Team
